B Author Coding Compared to Other Datasets

In the Table, I compare my coding of institutional, proportional, or no power-sharing to the UCDP, IMPACT, and PSED datasets. There exists differences across all four datasets. However, there are very few cases in which my coding differs from all datasets. First, I include the 1990 Jakarta Meeting of Belligerents to the (Cambodia), which none of the other datasets have. This is likely due to the fact that I include all negotiated agreements in the data since my unit of analysis is the actually power-sharing negotiation itself. Second, I include three cases from the Central African Republic that no other datasets includes. These cases represent three separate instances of the government and rebel groups coming together to agree to institutional power-sharing in the Central African Republic, culminating in the Bangui accords (Marchal et al. 2015). Third, I include two cases that resulted in no power-sharing in Cyprus (1967 and 1974). These cases lay outside of the time period analyzed by the other datasets and are thus excluded. Fourth, unlike the other datasets, I code the 1999 Lusaka accord as a case of institutional power-sharing because all signatories agreed to the inclusion of all parties under equal status in the future government. Fifth, I include the negotiated settlement to the 1992 South Ossetia conflict in Georgia, though I do not code this as power-sharing. Sixth, I code the 1992 The Protocol of Agreement between the Government of the Republic of Rwanda and the Rwandese Patriotic Front on the Rule of Law as institutional power-sharing because of its provisions on a national unity government.

D Coding Factionalization

In this section, I include a list of all negotiated peace agreements by each non-state actor and faction that was active at that time, according to their ethnicity. To find each faction, I list all factions considered active in the conflict according to the UCDP-factions dataset, including the government. I note any exceptions.

I also list each ethnic group according to the size of the ethnic group as given by EPR-ETH for the year encompassed by the peace agreement. For each rebel group, I consulted the secondary literature to see which ethnic group or groups it represented.

If only one faction is listed for that ethnic group, then that is the only major faction representing that ethnic group and I code it as unified in those negotiations. If a majority of the population, by size of ethnic groups, is unified, I note it in the final column.

I only list factions when a majority population does NOT exist.

F Sensitivity Analysis

As with any observational study, the potential presence of omitted variable bias prevents us from making causal inferences from the main results in the paper. To address this concern head on, I use a sensitivity analysis method developed by ? to estimate the magnitude necessary for an omitted variable to invalidate a inference about a given explanatory variable.¹ For each model, I estimate the “impact” necessary for an omitted variable to make the main explanatory variable lose statistical significance. Impact is defined as the product between the correlation of the main explanatory variable and the omitted variable and the correlation of the dependent variable and the omitted variable.

Table 9 summarizes the sensitivity analysis. For Model 1, which estimates the relationship between the presence of a majority group and the likelihood of institutional power-sharing, the impact of an omitted variable needs to be 0.174 to eliminate the statistically significance of the coefficient estimate for majority group. For comparison, this is larger than the impact of any of the three primary controls used in the analysis. It is extremely unlikely that either such an omitted variable exists or that I have not adjusted for this in either the main analysis or the comprehensive robustness checks. Similarly, for Models 3 and 4, in which the main explanatory variable is the presence of a unified majority of ethnic groups and a UN peacekeeping operation respectively, the impact level needed for the omitted variable to invalidate a causal inference is high enough to suggest that it is extremely unlikely that such a variable exists and has not been included in the analysis.

The impact level threshold for an omitted variable in Model 2, which tests the relationship between the likelihood of institutional power-sharing and the size of the largest group, is relatively lower. However, even in this case, with the exception of ethno-linguistic fractionalization, the impact level threshold is the largest of the major control variables, all of which are well-established in the literature as important causes of power-sharing agreements, factionalization, or both. This suggests that an omitted variable needs to be *more* important than GDP growth, the presence of a military stalemate, and the age of democratic institutions in order to invalidate a causal inference made about the size of the largest group. As such, it remains unlikely that an omitted variable exists for which I did not account given the number of variables adjusted for in the analyses.
